The following must be initialled and signed in order to receive flammable products. All information is kept confidential. This form protects you, the end user, by keeping pyrotechnics out of the hands of people who may do something inappropriate, thereby giving pyrotechnics a bad name and making it more difficult to purchase for future generations. Thank you for your patience and understanding : )

A clear, enlarged photocopy of your driver's license must also be supplied. Agreement must be mailed and received by us before order can processed.

The undersigned hereby acknowledges:
